In 2003/2004 and 2004/2005 I taught a course *Sociology of Family* for MA students of sociology at Faculty of Social Sciences, Charles University in Prague (in Czech). In 2003/2004 I taught two courses *Gender and society* for doctoral students at Pedagogical Faculty, University of South Bohemia, and for students at College Perspektiva (in Czech; together with colleagues).
